Business visa:

Single, double, or multiple tourist visa, with each stay up to 30 days – requirements:

- passport
- photo
- visa application
- a letter to the Consul (in English)
- air ticket reservation
- hotel reservation
- employment certificate
- invitation from a foreign company (in English)
- delegation letter (in English)

Set of documents should be sent via courier service to the Weco-Travel office in Warsaw.

ADDITIONAL INFORMATION

- A passport has to be valid for a minimum of 6 months longer than the expiration date of the future visa.
- A passport must have a minimum of 2 blank pages intended for visas (preferably adjacent to each other and without any stamps or traces of other visas).
- When crossing the border, there is no obligation to show a return ticket, but the traveler should have a ticket and other documents for onward travel or return.
- Important: Please check the technical condition of your passport and the number of blank pages. The passport must not have any technical damages (please check the condition of the first photo page of the passport).
