## **ADDITIONAL INFORMATION**

Namibia does not have a diplomatic mission in Poland, therefore we process applications through the Embassy in Berlin. Documents should be completed in English. The application should be completed on the computer (all fields must be filled). The visa is issued for 30 days. From August 22, 2019, Polish citizens can also apply for a tourist visa when entering Namibia at the Windhoek Hosea Kutako airport.

The validity of the passport must be 6 months longer than the validity of the visa. When crossing the border at the airport, you must show a return ticket.

#### Important:

Please check the technical condition of your passport and the number of blank pages. The passport must not have any technical damages (please check the condition of the first photo page of the passport).
