BASIC INFORMATION

Waiting time:

Standard mode: 1 week
Express mode: 3 workdays

* express mode is available provided only that an applicant has an invitation confirmed by the Russian Ministry of Foreign Affairs. If the client applies for a 1-year visa basing on the invitation issued by a company, the realization period may be extended to 10 workdays.

VISA

Tourist Visa:

A visa is issued for max. period of 30 days, however, ultimately the coinciding period apply which is present in visa application form, tourist voucher and attached insurance – requirements:

- Passport
- Visa application form filled in online
- Color passport photograph (on white background) with dimensions of 35mm x 45mm
- Compulsory insurance covering the territory of Russia
- Tourist voucher and foreign tourist reception confirmation

Business visa:

A visa is issued for the coinciding period, which is present in visa application form, invitation and attached insurance. It may be issued as a single, double or multiple visa. Visa validity according to the period indicated on the application: single (max. 30 days), double (max. 90 days), multiple (max. 90 days for each 180 days of visa validity).

- Passport
- Visa application form filled in online







- Color passport photograph (on white background) with standard dimensions of 35mm x 45mm
- Compulsory insurance covering the territory of Russia
- Invitation from a Russian company

Set of documents should be sent via courier service to the Weco-Travel office in Warsaw.

ADDITIONAL INFORMATION

Invitations issued by Russian companies are also acceptable (with some reservations).

Above-mentioned invitations apply only to Schengen Agreement countries. Invitations may be issued directly by a given company. It is possible to present a computer scan of the invitation (in color and high resolution). A company's invitations should fulfill the following conditions:

It should be written on a company's headed paper, signed by a Director, and stamped with an official blue, round seal. Such an invitation should also include the following data: name and surname of the invited person, date of birth and passport number, a detailed specificity and purpose of the travel, information on that, who is the payer of this travel, and who will be liable for deportation costs in case of such an event, including a request for visa (single, double or multiple) and specific dates (a precise range must be given – accordingly either for 30, 90, 180 days or 1 year period).

Russian consulates are subject to regionalization. Selection is made on the basis of the authority issuing a passport.

We are able to organize both a tourist voucher and insurance. There is also a possibility of obtaining an invitation confirmed by the Russian Ministry of Foreign Affairs. Realization time of an invitation is from 10 to 25 workdays and the cost of such a service amounts to a sum of PLN 500 – PLN 1000.

The passport has to be valid for at least 6 months longer than the end of validity of the future visa and have at least 2 blank pages (without any stamps or slides from other visas), preferably adjacent to each other and intended for visas.

Important:

Please check the technical condition of your passport and the number of blank pages. The passport must not have any technical damages (please check the condition of the first photo page of the passport).
